INTRODUCTION

The Chairperson welcomed all those present and explained the functions of the Canterbury Bankstown Local Planning Panel and that the Panel would be considering the report, recommendations from the Council staff and the submissions made by objectors.

CONFIRMATION OF PREVIOUS MEETING

The Chair noted that the minutes of the Canterbury Bankstown Local Planning Panel meeting held on 13 October 2025 had been confirmed as correct.

1. DA-598/2025 - 2 and 4 Vimy Street, Bankstown

Construction of a five-storey residential flat building with 17 residential units (one for affordable housing) above two levels of basement car parking

Site Visit

An inspection of the site was undertaken by the Panel and staff members prior to the public hearing.

CBLPP Determination

THAT Development Application DA-598/2025 be REFUSED.

Vote: 4 - 0 in favour

Reasons for decision

The Panel agrees with the Council staff recommendation that the application should be refused and agrees with the Reasons for Refusal in the Council Assessment Report and the following reasons:

- The proposed development fails to respond to its context which includes special features in its immediate locality being the heritage listed War Service Housing Commission dwellings, and Bankstown Memorial Park, as well as Bankstown City Gardens.
- This lack of connection to the locality also results in a missed opportunity for the development to address the parkland views and create the significant increase in amenity that this would achieve for residents.
- The Panel also notes the inconsistencies with the Design Principles in Chapter 4
 of SEPP Housing and its flow on impacts which have resulted in a significant
 number of noncompliances with the Apartment Design Guideline. These
 significant failures to achieve design excellence result overall in a poor-quality
 design that would produce inadequate amenity for future residents.
