

## **Statement of Ethical Obligations**

#### Oath or Affirmation of Office

In taking the Oath or Affirmation of Office, each Councillor has made a commitment to undertake the duties of the office of councillor in the best interests of the people of Canterbury Bankstown and Canterbury Bankstown Council and that they will faithfully and impartially carry out the functions, powers, authorities and discretions vested in them under the Local Government Act 1993 or any other Act to the best of their ability and judgment.

#### **Conflicts of Interest**

A councillor who has a conflict of interest in any matter with which the council is concerned, and who is present at a meeting of the council when the matter is being considered, must disclose the interest and the nature of the interest to the meeting as soon as practicable. Both the disclosure and the nature of the interest must be recorded in the minutes of the Council meeting where the conflict of interest arises. Councillors should ensure that they are familiar with Parts 4 and 5 of the Code of Conduct in relation to their obligations to declare and manage conflicts of interests.



## Mayoral Minutes - 18 April 2023

#### ITEM 4.1 Local Government Summit

Councillors,

No matter where I go these days, the topic of conversation most people want to engage you on, is the cost of living.

Rising interest rates, increasing electricity bills, skyrocketing meat and grocery costs at the supermarket - and that's not mentioning house prices, soaring rents, or hiring a tradie!

At every turn, from the petrol bowser, to your health and home insurance people are paying more and they are feeling the pain.

And like our ratepayers, and many other councils across the State, our costs and the costs of doing business have also increased. Whether it's an increase in the cost of materials, or labour hire and contractors, they are just some of the burdens on the budget.

And as you are all aware our revenue stream is limited, and let's be under no illusion, the current system is broken.

Councillors, our sector has been crying out for financial reform and relief for some time but under the previous Minister all we got was a lot of talk and no action.

Tonight, I propose writing to the recently appointed Minister for Local Government, The Hon. Ron Hoenig MP, congratulating him on his appointment and calling on him to convene a Local Government Summit, to examine the sustainable funding of the Local Government sector to ensure its viability and future.

Councillors, I put the Mayoral Minute.

## **Mayoral Minutes - 18 April 2023**

### ITEM 4.2 Dunc Gray Velodrome, Bass Hill

Councillors,

The 2000 Olympics was a major coup for Sydney and indeed for our City. For five days, the world watched as some of the greatest cyclists competed for Olympic glory at the Dunc Gray Velodrome at Bass Hill.

A velodrome which cost NSW taxpayers around \$42million.

I don't intend to go over old ground tonight, or canvas the countless stories written about the future of the site, except to say we have been left to manage and maintain this State facility along with the NSW Government.

A massive investment that is ongoing . . . year in, year out.

The velodrome sits on a huge parcel of land at The Crest and covers an area of about 11,000 square metres. Along with it being used for all levels of cycling and training, it also caters for indoor hockey and soccer and other sports events.

Councillors, with a change of Government comes new opportunities, and we must seize the moment to spruik our case for more support. You would all recall the funding dolled out by the previous Government under WestInvest and how our City was unfairly treated. . . I refer of course to missing out on vital funding for our leisure and aquatics centres and numerous other projects.

But all is not lost as there are still millions of dollars yet to be allocated. I refer of course to an application for funding for the velodrome which we understand was submitted by the NSW Government Office of Sport.

We are in the race and a real chance!

So tonight, I propose we write to the newly appointed Minister for Sport, The Hon. Steve Kamper MP, congratulating him on his appointment and asking him for whatever assistance he can give in relation to funding and the future of the Velodrome site.

#### ITEM 4.3 Local Community Based Donations

In accordance with Clause 5.1.5 of Council's Community Grants and Event Sponsorship Policy, the following community-based organisations have approached Council for financial assistance.

#### **Bankstown Sports Little Athletics Centre Incorporated**

Bankstown Sports Athletics Club has contacted Council seeking financial support for Filtomas Finekifolau who is representing the Club at the '2023 Chemist Warehouse Australian Junior Athletics Championships'.

The Championship are being held in Brisbane, QLD from Thursday 13 April until Sunday 16 April 2023 and although Filtomas is 13 years old, he will be competing in the under 15-year boys. Filtomas has been selected to participate in four separate events; hammer throw, discuss, shot put and javelin.

Filtomas' single mother has paid for all of the expenses associated with his trip to QLD and via their athletics club, is hopeful of financial support.

Bankstown Sports Little Athletics Centre Incorporated is seeking Council's support by way of a \$1,000.00 donation to go towards the costs associated with flights, uniforms, entry fees and accommodation for Filtomas.

#### **Australian International Multicultural Association (AIM Association)**

The AIM Association is a non-profit organisation dedicated to promoting and supporting business growth with a focus on multiculturalism. Our mission is to foster an environment of collaboration and innovation that helps businesses thrive by working together.

The AIM Association Business Awards is being held on the 19 May 2023 at Doltone House Bossley Park. This is an annual event that celebrates and recognizes the achievements of businesses, non-profits, and entrepreneurs in their respective fields. It is a platform that acknowledges excellence and innovation and provides an opportunity for organisations to showcase their success stories.

The Awards highlight the importance of entrepreneurship and business growth with an emphasis on multiculturalism and bringing together like-minded individuals to network and learn from each other.

The AIM Association is seeking Council's support of this event, by way of a donation from Council of \$2,200 towards this event.

In recognition of Council's support of this event, AIM Association will mention Council in the Awards Night Program, Council's logo will be displayed at the event and Council will be allocated a table of 10 at the event.

#### AusRelief "Iftar Under the Stars"

AusRelief hosted "Iftar Under the Stars" on 6 April 2023 at Parry Park, Lakemba.

The event is aimed at bringing together the local community members of different faiths and backgrounds to break the fast together during the holy month of Ramadan.

This event is a significant opportunity for community integration and plays an essential role in building stronger bonds between the diverse members of our community.

The event will include a communal meal and will serve as an opportunity for individuals and families who may not have access to such events to celebrate the spirit of Ramadan with their fellow community members.

This event not only promotes social cohesion but also serves as an excellent platform for fostering mutual respect and understanding among people of diverse backgrounds.

AusRelief are seeking Council's support of this event, by way of a fee waiver for the ground hire fee of Parry Park, equating to \$508.00

#### **Community Minds Inc.**

Community Minds offers innovative and engaging community programs and initiatives that place the community at the centre of the work we do. Engaging diverse stakeholders, including children and young people ensures we cultivate and create communities that are asset-focused, abundant and adaptable.

Community Minds are hosting a small-scale event for children as a school holiday event, with the highlight being boomerang painting with local elder and artist, Aunty Noelene. They will be providing other interactive activities and hear from the families/community what they love about Canterbury Bankstown and what they can contribute to make it a better place. Community Minds will also provide families with information about local initiatives and services.

Community Minds are seeking Council's support by way of a \$156.00 fee waiver for the hire of the space they will be occupying outside the Bankstown Courthouse on Thursday 20 April 2023.



# ITEM 10.2 Interim Heritage Order - St Paul's Anglican Church - Chapel Road, Bankstown

I, Councillor Barbara Coorey hereby give notice that at the next Ordinary Meeting of Council I will move the following motion:-

"That Council institute an emergency Interim Heritage Order for the Bankstown Anglican Church (St Paul's Anglican) site at 459 Chapel Road, Bankstown."

#### **BACKGROUND**

I rely on the Report by Sue Rosen and Associates dated February 2016 which contains a supplementary heritage advice for St Paul's Anglican Church, 459 Chapel Road, Bankstown.

St Paul's is demonstrative of the work of the architect Norman Wellard McPherson who was responsive to trends in ecclesiastical architecture in the interwar and post war Eras. He has designed a number of significant Anglican, Methodist and Congregational Churches.

The site at 459 Chapel Road Bankstown is comprised of the church and rectory with its unusual pre-reformation and almost monastic grounds. The church fabric is locally noteworthy with quality brick work and timber joinery and fittings and the tower provides a stunning landmark.

The Church has local historic associative significance due to its association documented in the walls, in the windows and furniture and fittings with the involvement of the Engisch and Fitzpatrick families.

St Paul's parishioners, Alan Richard Maunsell (died in 1944 on a HMAS ship hit by the Japanese Suicide pilot) and Bruce Marshall died in 1942 WW2 in Papua. Both aged 21 and both had been parishioners of St Paul's. Alan Maunsell was a Sunday school teacher at the church. Bruce Marshall was the son of the Minister Hugh Marshall at St Paul's.

Of note is the fact that there are three other churches (as at the date of the February 2016 report) designed by McPherson which are heritage listed items by their respective councils being as follows:

- The Mosman Uniting Church and Hall, 38a Balmoral Road, Mosman
- The Uniting Church Group (comprising Church, Personage and Fence), 134 Wagonga Street, Naroome (Eurobedella Shire)

• The All Saints Cathedral Group at Bathurst (1970 Works), 11 Church Street, Bathurst (Bathurst Regional Council)

Of note there exists at least 35 plaques in the garden dedicated to families and World War II veterans and Father Tony Ward who served at St Paul's for 30 years.

On a final note we as a council are not in the business of allowing churches to be demolished for high rise development. We need to respect our past in order to succeed into the future.

It is inconceivable to even to think of any demolition of this magnificent building (which is not only on heritage and local significance) but the fact that the ashes of a Minister Thomas Ian Lawrence who passed away in 1981 - are interred in the alter of the Church.

#### FINANCIAL IMPACT

There is no financial impact for this motion

#### **CHIEF EXECUTIVE OFFICER'S COMMENT**

In 2015, the former Bankstown City Council resolved to use its delegation under the *Heritage Act 1977* to make an Interim Heritage Order for the site however, in 2016, Council resolved not to proceed with the proposed heritage listing.

The delegation does not permit Council to make a further Interim Heritage Order for the same site, however, the Minister may make an Interim Heritage Order if supported by Council and found to have State or local heritage significance. This matter would be referred to the Minister for consideration.

# **BACKGROUND**

On 22 November 2022 Council supported a motion at Item 10.6 - Greening of Unwin Street, Earlwood to oppose the sale of the lands in Unwin Street, Earlwood.

This Council stands united with the Wolli Creek Preservation Society in their aim to connect Waterworth Park to the Regional Park, to improve water quality, protection of local wildlife and strengthening of the Sydney Green Grid.

The reclassification will ensure more green open space not only for our local residents in Earlwood but also assists with the provision of functional open space connected to a wonderful unique urban bushland for future generations.

#### FINANCIAL IMPACT

I anticipate that Council staff would be able to prepare the Planning Proposal within the available resources.

# CHIEF EXECUTIVE OFFICER'S COMMENT

In November 2022 Council resolved to voice their opposition to any proposed sale of vacant Sate Government land in Unwin Street, and support it being handed over to the National Parks and Wildlife Service. The proposed motion is consistent with this resolution.

Should Council prepare a planning proposal to rezone the site for public purposes, it would need to be consistent with the Ministerial Direction 5.2 – Reserving Land for Public Purposes. The Ministerial Direction does not permit planning proposals to alter existing zonings without the approval of the relevant public authority and the Planning Secretary.

# ITEM 10.4 Tarawih - Ramadan Nights Lakemba 2023

I, Councillor Bilal El-Hayek hereby give notice that at the next Ordinary Meeting of Council I will move the following motion:-

"That Council assists the local community to hold Tarawih (Ramadan Prayers) in Haldon Street on Wednesday 19 April 2023."

#### **BACKGROUND**

Canterbury Bankstown is the talk of the town with Ramadan Nights Lakemba proving to be one of Australia's most popular cultural events. While there has been a focus on the vibrant, global food bazaar that occurs every night, it is important not to forget the true meaning of the holy month of fasting, introspection and renewal that underpins this event.

An event which has once again attracted a record-breaking number of visitors - more than one million people from across our city and around the country. And as this highly successful celebration comes to a close, there is an opportunity to bring these two important activities together.

To achieve this, I am proposing that Council assists the local community to hold Tarawih (Ramadan Prayers) for one hour on the second last day of Ramadan. This will provide not only an opportunity for the local community to pray but will also inform and celebrate the true meaning of Ramadan to the thousands of visitors that visit Ramadan Nights Lakemba.

#### FINANCIAL IMPACT

I understand that Council already has in place a budget for managing this event and anticipate that this will only require a small adjustment to manage this 1-hour event.

# **CHIEF EXECUTIVE OFFICER'S COMMENT**

While the principles of allowing a community Ramadan Prayer is supported, this comes with significant operational challenges and the Police have indicated that they do not support this within the main event area of Haldon Street unless supported by Council.

A preliminary review of safety, security, traffic management, evacuation planning and staffing has been undertaken and it has been determined that the event could proceed subject to the following:

- The event is to be for 1 hour from 7:30 to 8.30PM (plus bump in and out time)
- an exclusion zone will be set up between Oneata Street and Gillies Street
- measures will need to be put in place to manage the safe movement of pedestrians
- additional infrastructure to manage people movement
- impacted stalls will be required to stop trading for the period
- The police will support Council with orderly conduct of the event and surrounds
- organisers will need to manage the prayers within the restricted area
- organisers will need to manage any sound amplification within acceptable levels and will not be allowed before or after the designated time
- organisers will be required to work with Council and the police to ensure all of the above are managed
- additional communication will be required to inform the community

It is imperative that Council continues to provide a safe event for all attendees. For this to occur in a safe and orderly manner further assessment will be undertaken and additional measures in addition to the above may be required.

The outcomes of this trial event will also be fed into the broader review of Ramadan Nights Lakemba currently underway. Anticipated extra costs could be in the order of \$20,000 however this will be reviewed as further information is obtained.
